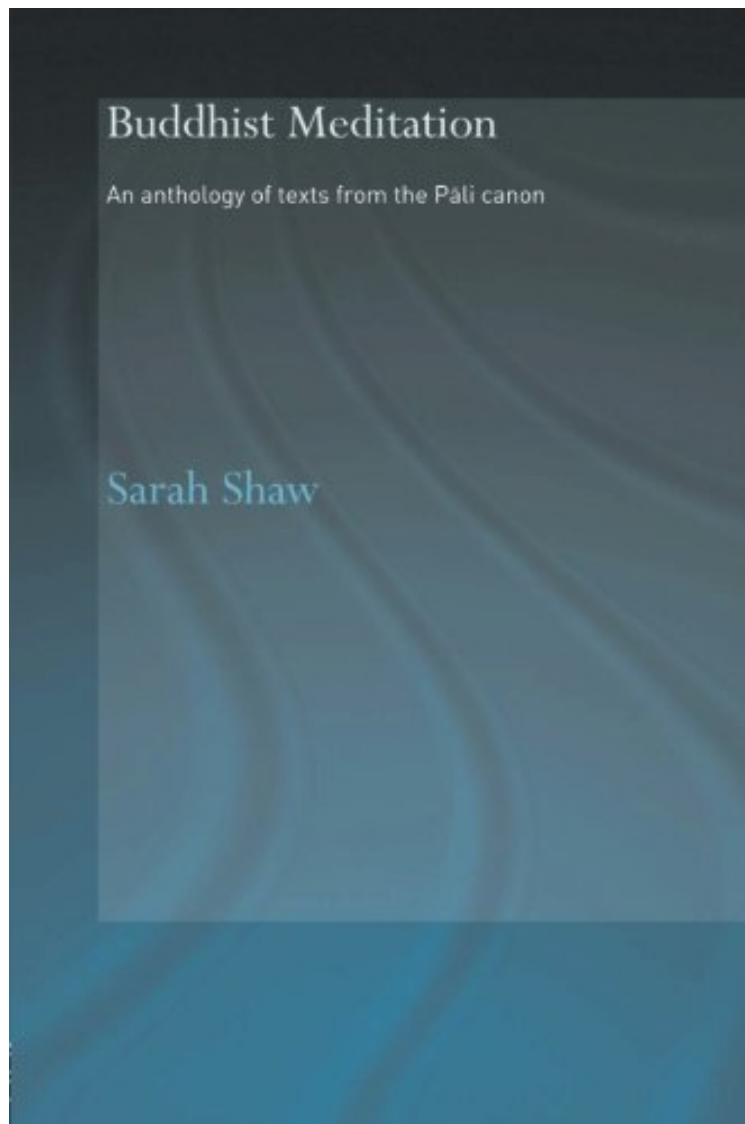

In whom there are both meditation and wisdom: he is, indeed, close to nibbana. (Dhammapada, 371-4) Although many Buddhists practise meditation, few have the time or inclination to examine the early teachings on meditation in the Pali Canon and see for themselves what the Buddha taught. There are many how to books now on the market to teach the basics of meditation. They are useful but often fall into the trap of divorcing meditation from the wider practice for which it can provide the bedrock. It is thus helpful to find academic work that gives non-scholars access to well-executed translations of key passages of major texts. prompted by Richard Gombrich, whose knowledge of the existing Pali translations could point out their deficiencies. Shaws study produces welcome new translations of those passages. There is a useful Introduction on the practice of mediation in the Buddhist tradition, including explanations of samattha and vipassana. Passages from the Pali Canon are accompanied by relevant extracts from the works of early commentators Buddhaghosa and Upatissa, as well as from those of contemporary Theravada teachers. The book is written for an academic audience, but its content and its structure, which is based around short sections, each covering a different aspect of meditation, makes it useful for meditation teachers who wish their students to learn about and reflect on the early teachings in order to inform and deepen their practice.

Meditative practice lies at the heart of the Buddhist tradition. This introductory anthology gives a representative sample of the various kinds of meditations described in the earliest body of Buddhist scripture, the Pali canon. It provides a broad introduction to their traditional context and practice and supplies explanation, context and doctrinal background to the subject of meditation. The main themes of the book are the diversity and flexibility of the way that the Buddha teaches meditation from the evidence of the canon. Covering fundamental features of Buddhist practice such as posture, lay meditation, and meditative technique it provides comments both from the principal early commentators on Buddhist practice, Upatissa and Buddhaghosa, and from reputable modern meditation teachers in a number of Theravadin traditions. This is the first book on Pali Buddhism which introduces the reader to the wide range of the canon. It demonstrates that the Buddha's meditative tradition still offers a path of practice as mysterious, awe-inspiring yet as freshly accessible as it was centuries ago, and will be of interest to students and scholars of Buddhism as well as Buddhist practitioners.
